## What types of activities are ineligible?

An ineligible activity may not be included in CI Hours as outlined by the Ministry of Education:

- is a requirement of a class or course in which the student is enrolled (e.g., cooperative education portion of a course, job shadowing, work experience)
- takes place during the time allotted for the instructional program on a school day. However, an activity that takes place during the student's lunch breaks or "spare" periods is permissible
- contravenes the minimum age requirements to work in or visit a workplace stated in regulations made under the Occupational Health and Safety Act
- contravenes any other applicable legislation, regulation, or policy
- contravenes the policies and procedures of the organization that is supervising the student's community involvement activities
- would normally be performed for wages by a person in the workplace
- involves the operation of a vehicle, power tools, or scaffolding
- involves the administration of any type or form of medication or medical procedure to other persons
- involves handling of substances classed as "designated substances" under the Occupational Health and Safety Act
- requires the knowledge of a tradesperson whose trade is regulated by the provincial government
- involves banking or the handling of securities, or the handling of jewelry, works of art, antiques, or other valuables
- consists of duties normally performed in the home (i.e., daily chores) or personal recreational activities
- involves activities for a court-ordered program (e.g., community-service program for young offenders, probationary program)
- involves activities that promote discrimination, harassment, or puts the safety of the student or others at risk

## What types of activities are eligible?

Eligible activities are volunteer activities (unpaid) that may be counted towards the CI hours required to graduate and provide services to improve the well-being of the school, community, or not-for-profit institutions. Please see the following list of **possible activities**. Please note that ALL activities should be approved by a parent/guardian BEFORE participating. If unsure about an activity's eligibility, please speak with the Guidance Counsellor BEFORE participating.

#### **HELP YOUR COMMUNITY**

- volunteer at a seniors' home/centre
- help organize local community events (food drives/banks)
- take part in environmental initiatives (recycling campaigns, park cleanup)
- get involved in charitable activities (walk-a-thons, etc.)
- assist with sports teams but not as a player
- volunteer in leadership roles with community groups youth groups
- volunteer in hospitals, libraries or any charitable, not-for-profit organization
- volunteer with social service or animal welfare agencies
- offer service through religious communities/places of worship
- assist with literacy initiatives at local libraries, day care centres, community centres
- get involved in the democratic political process—canvassing, campaigning, etc.

### **HELP YOUR SCHOOL OR OTHER SCHOOLS**

- help with sports teams but not as a player
- assist with school events
- tutor other students (must be facilitated by a teacher and approved by Guidance Department)
- assist with the planning of extracurricular or school events that benefit the community
- participate in charitable initiatives (food and clothing drives, holiday drives)
- sit on school committees (be a peer mentor/mediator, help with orientation of grade 9 students, student ambassador)

#### **HELP YOUR NEIGHBOURS**

- provide service to seniors or others who have difficulty leaving their homes (raking, shoveling, shopping, meal preparation). Students should not drive vehicles for this purpose.
- assist a neighbour with child care
- tutor younger students
- · assist with pet sitting
